Adoption of Subcommittee Rules

Mr. Hubinger reviewed the proposed changes of the subcommittee rules. Discussion ensued. Sen. Kelley moved to change the language on page 1, line 7, delete the new language and insert, "through December 31 of the even-numbered years".

Sen. Scheid took the vote on Sen. Kelley's motion to adopt the rules, including the change to the language on page 1, line 7. The motion was adopted.
