 - a) Agreement with the Minnesota State College Faculty, submitted to the Subcommittee on June 29, 2009;
 - b) Agreement with the Minnesota State University Administrative and Service Faculty, submitted to the Subcommittee on June 29, 2009.

- 2) Approve the terms of the following negotiated agreements entered into between the exclusive representatives of the state bargaining units and the Commissioner of Minnesota Management and Budget:
 - a) Agreement with the American Federation of State, County and Municipal Employees, Council 5, submitted to the Subcommittee on June 29, 2009;
 - b) Agreement with the American Federation of State, County and Municipal Employees, Council 5, Unit 8, Correctional Officers, submitted to the Subcommittee on June 29, 2009;
 - c) Agreement with the American Federation of State, County and Municipal Employees, Council 5, Unit 225, Radio Communications Operators, submitted to the Subcommittee on June 29, 2009;
 - d) Agreement with the Minnesota Association of Professional Employees, submitted to the Subcommittee on June 29, 2009;
 - e) Agreement with the Middle Management Association, submitted to the Subcommittee on June 29, 2009.

- 2) Authorize the Commissioner and the Chancellor to implement the terms of the agreements;

- 3) Require the Commissioner or the Chancellor to submit a copy of each memorandum of understanding or memorandum of agreement between these exclusive

representatives and the Commissioner or Chancellor to the Subcommittee on Employee Relations within three days of its execution; and

- 4) Instruct staff of the Subcommittee, in consultation with the Commissioner and the Chancellor, to prepare legislation necessary for final legislative approval of the agreements.
